#### **Promotion Period**

This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook (Meta). By entering, participants agree to release Facebook from any liability associated with this promotion.

#### **Eligibility**

Entry is open to residents of Australia aged **18 years or over**. Employees of the Promoter and their immediate family members are not eligible to enter.

## How to Enter

To be eligible, entrants **must complete ALL of the following five (5) steps** during the Promotion Period:

1. **Comment** on the promotional Facebook post with your guess of the correct score
2. **Place an order** with Salami Bros (either in-store or online) during the Promotion Period
